MINUTES

REORGANIZATION MEETING -- JANUARY 6, 2020

The Reorganization Meeting of the Lower Swatara Township Board of Commissioners was called to order at 6:00 P.M. by Solicitor Peter R. Henninger. Solicitor Henninger then turned the floor over to The Honorable Judge John Cherry, Dauphin County Court of Pleas, who presented the oath of office to Commissioner-elect Michael J. Davies, Commissioner-elect Todd F. Truntz, and Commissioner-elect Jon G. Wilt.

Solicitor Henninger called for nominations for President of the Board. Commissioner Davies nominated Jon G. Wilt as President. Hearing no other nominations, the motion to appoint Jon G. Wilt as President was approved by a 3-2 margin, with Commissioner DeHart and Commissioner Paul dissenting. The gavel was then turned over to President Wilt.

President Wilt called for nominations for Vice President of the Board, and nominated Todd F. Truntz as Vice President. Hearing no other nominations, the motion to appoint Todd Truntz as Vice President was unanimously approved.

President Wilt called for nominations for Township Secretary, and nominated

Jean R. Arroyo as Township Secretary. Hearing no other nominations, the motion to elect

Jean R. Arroyo was unanimously approved.

President Wilt called for nominations for Assistant Secretary. Commissioner Davies nominated Ronald J. Paul as Assistant Secretary. Hearing no other nominations, the motion to appoint Ronald J. Paul was unanimously approved.

Solicitor Henninger noted the Board is now in a position to act on Resolution No. 2020-R-1. Township codes requires the Board appoint the Assistant Township Secretary by resolution. A motion was made by Commissioner DeHart, seconded by Commissioner Davies, to approve Resolution No. 2020-R-1, which appoints Ronald J. Paul as Assistant Township Secretary. The motion was unanimously approved.

The Board tabled the reappointment of Herbert, Rowland & Grubic as Township Engineer.

A motion was made by Vice President Truntz, seconded by Commissioner Paul, to reappoint Peter R. Henninger, Jones & Henninger, P.C., as Township Solicitor.

Vice President Truntz noted that while a lot of these reappointments may seem routine, he would like to add that Solicitor Henninger is a very trusted member of this team. Solicitor Henninger has a long history serving the Township, which carries with it a lot of knowledge. The motion was unanimously approved.

A motion was made by Commissioner Davies, seconded by Commissioner DeHart, to reappoint RKL, LLP as Township Auditor. The motion was unanimously approved

A motion was made by Commissioner Davies, seconded by Vice President Truntz to approve the reappointment of Keystone Collections Group as Earned Income Tax Collector. The motion was unanimously approved

A motion was made by Commissioner Davies, seconded by Commissioner Paul, to approve the reappointment of Mid Penn Bank as Township Depository. The motion was unanimously approved.

A motion was made by Commissioner DeHart, seconded by Vice President Truntz, to approve the reappointment of Powell, Rogers & Speaks as Lower Swatara Township delinquent tax collector for Act 511 taxes for the year 2010 and prior. The motion was unanimously approved.

A motion was made by Commissioner Davies, seconded by Commissioner DeHart, to approve the reappointment of Berkheimer Tax Administrator as delinquent tax collector for Act 511 taxes for the year 2011 – 2019. The motion was unanimously approved.

A motion was made by Commissioner Paul, seconded by Commissioner DeHart, to confirm the list of Special Fire Police for the year 2020: Captain Dave Rhine, Lieutenant Henry Pickle, Jodie Frazier, Jackie Leonard, and Tyler Ross. The motion was unanimously approved.

A motion was made by Commissioner DeHart, seconded by Commissioner Davies, to approve the appointment of Julie Wilt as Township Treasurer. The motion was unanimously approved.
